

KYC FOR DIRECT SELLER

As per the Guidelines for Direct Selling published by the Ministry of Consumer affairs it is mandatory that KYC documents and signed Legal Agreement be sent to the Company to complete registration with the company as a Direct Seller.

Direct sellers are required to submit their physical KYC documents with duly signed Direct Seller Agreement as available on the legal section of this website. This is mandatory as per Government Guidelines. The agreement duly signed along with all KYC documents needs to be couriered to the Company Office in Gwalior. Henceforth only those direct sellers would get payout cheques, whose physical

KYC and duly signed Direct Seller Agreement has been received by the company.
